#### **PUBLIC COMMENTS -**

• Bill Kelly, 1511 Sheridan Street, Williamsport, PA 17701

Mr. Kelly commented that the Board of County Commissioners endorsed a personal income tax to reduce taxes on residential properties. He questioned why so few schools have adopted a personal income tax. Mr. Vuocolo responded that one of the main reasons was that we currently have a mechanism to collect earned income tax in place. Mr. Yaw commented that there were no regulations in place when many schools proposed this recommendation. He further stated that the regulations have just recently passed by legislation. Mr. McLaughlin commented that in his opinion there would be additional proposals to reduce property taxes and that could include an increase in sales tax or some other form of tax.

• Ray McGinnis, 1016 Dawn Drive, Williamsport, PA 17701

Mr. McGinnis commented that the State funding for education has decreased from approximately 50% many years ago. The current amount is approximately 35%. He asked if the State would be increasing this percentage in the near future. Mr. McLaughlin responded that, in his opinion, increases would not approximate the funding levels of the 1970s.
