

ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a Safe Return to In-Person Instruction and Continuity of Services Plan, hereinafter referred to as a Health and Safety Plan.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The Loyalsock Township School District is committed to providing in-person learning to the maximum extent possible. The District will continue to consider information and guidance received from the Center for Disease Control, the Pennsylvania Department of Health, and the Pennsylvania Department of Education.

The Loyalsock Township School District will continue to utilize a broad range of services to ensure the continuity of services including academic, social, emotional and mental health needs. To support both students and staff, we will utilize our counselors, school outreach worker, trauma counselor, outside mental health and support agencies and mental health programs. We will continue to provide food services for all students and students will be entitled to one free breakfast and one free lunch each school day during the 2021-2022 school year. The continuity of services will continue regardless of the in-person or remote learning.

Students and staff who test positive will be quarantined as recommended by the CDC. Asymptomatic close contacts will not be required to be quarantined. A weekly notification identifying the number of positive cases per building will be communicated via the school notification system.
